## 5<sup>th</sup> Phase (Walk-in) Admissions into Government ITIs /ATCs / RITIs / MINORITY ITIS AND Private ITIs for August-2025 Session.

- 1. Applications are invited for Walk in admissions for the session 2025 2026 from 13-10-2025 onwards.
- 2. Qualification:- Person having educational qualification as 10<sup>th</sup> Pass / 8<sup>th</sup> Pass can take admission in ITIs. The required minimum qualification is prescribed in the respective trade syllabus, as well as in the list of Trades under Craftsmen Training Scheme (CTS) given in the website. For the course of Drone technology the minimum age limit it 16 years.
- 3. Age:- Candidates who have attained the age of 14 years as on the date of commencement of academic session i.e 1-8-2025 are eligible for admission. There is no upper age limit for candidates seeking admission in course under Craftsmen Training Scheme.
- 4. Interested fresh candidates have to register & apply in the website. However, already registered candidate need not register again they have to attend to the Walk-In.
- 5. All the candidates who have applied for admissions into ATC's/ITI's/Pvt ITI's during 1<sup>st</sup> phase 2<sup>nd</sup> phase, 3<sup>rd</sup> Phase, and 4<sup>th</sup> phase and did not secure admission into any of the ITI can directly walk in for admission into any of the Govt. ITI/ATC or Pvt ITI.
- 6. Candidates who have submitted their application earlier in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> and 4<sup>th</sup> phase admissions for the session 2025 and got verified are eligible for direct Walk in admissions.
- 7. Candidates who have submitted their application earlier in 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> phase admissions for the session 2025 and did not get application verified are also eligible for direct Walk in admissions.
- 8. Online application is a must for admission into ATC/ITI/Pvt ITI. Without Online application admission will not be considered into ATC's/ITI's/Pvt ITI's.
- 9. The website address is <a href="https://iti.telangana.gov.in">https://iti.telangana.gov.in</a> to apply for online admissions into ATC's/ITI,s in Telangana state.
- 10. Those applications which are received up to 01.00 PM will be considered for Walk in admissions for that day.
- 11. Applications received after 01.00 PM will be considered for next day Walk in-admissions.
- 12. Candidates who have got seats in 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> phase admissions and have reported can also submit options for sliding into other ATC's/ITI's/Pvt ITI's. Those candidates who get admission through sliding have to move over to the revised allotment. The admission secured in 1<sup>st</sup>

- and 2<sup>nd</sup> phases will automatically be cancelled. If they do not report as per admission got in sliding option, within the time, both the seats will remain cancelled.
- 13. There will be no sliding option for those who secure admission in Walk in admissions. No discharge option will be given for the reported candidates.
- 14. The candidates seeking admission in particular Government/ ATCs / Private ITI has to attend to the Respective I.T.Is with all original certificates along with online downloaded application form obtained from Portal.
- 15. The Candidates who are seeking admission into vacant seats of Govt. ITIs/ Private ITIs can attend from 9.00am to 1.00 pm where the candidate wishes to appear either to Govt. or Private ITI.
- 16. In case, if the candidate does not get seat on that day the merit day he can attend at other Govt. / Private ITI for securing seat and so, on up to 17-10-2025.
- 17. The availability of seats in Govt. ATC's/ITI's and Pvt. ITI's will be updated daily in the morning and the candidate can attend where the vacancies are available as on that day as her per his interested trade or ITI.
- 18. The candidate once admitted on any day from 13.10-2025 to 17 -10-2025 is final and no second chance /option will be given.
- 19. The seats will be allotted daily as per merit from common merit list. The admissions will be as per attendance day wise merit list.
- 20. All the Original Certificates shall be scanned and uploaded in the website in case of fresh candidates.
- 21. All the admissions are subject to clarifications / Instructions issued by State Government and DGT, New Delhi from time to time.
